Notice of "Partial Amendments to the Articles of Incorporation"

Demae-can Co., Ltd. (the "Company") announces that its Board of Directors has resolved at a meeting held today to submit a proposal for "Partial Amendments to the Articles of Incorporation" to the 23rd Annual General Meeting of Shareholders scheduled to be held on November 29, 2022, as follows.

Detail

1. Reason to amend

The revised provisions stipulated in the proviso of Article 1 of the Supplementary Provisions of the "Act Partially Amending the Companies Act" (Law No. 70 of 2022) came into effect on September 1, 2022. In accordance with this, a new provision shall be established to take measures for electronic provision of information, the contents of reference documents for the Annual General Meeting of Shareholders, etc., and to limit the scope of matters to be included in documents to be delivered to shareholders who have requested delivery of such documents, and the provisions regarding Internet disclosure of reference documents for the annual general meeting of shareholders and deemed provision of such documents are deleted. The Supplementary Provisions on Transitional Measures, etc. will be established.

- (1) Paragraph 1 of Article 15 of the Proposed Amendment will have the Company to take measures to provide information regarding the contents of reference documents for the Annual General Meeting of Shareholders, etc. electronically.
- (2) Paragraph 2 of Article 15 of the Proposed Amendment would establish provisions to limit the scope of matters to be included in the documents to be delivered to shareholders upon their request.
- (3) The provision for Internet disclosure and deemed provision of reference documents for the Annual General Meeting of Shareholders, etc. (Article 15 of the current Articles of Incorporation) shall be deleted as it is no longer necessary.
- (4) In connection with the above new establishment and deletion, the Supplementary Provisions regarding transitional measures, etc. will be established. This Supplementary Provision will be deleted after the expiration date.
